Proficiency Testing Canada (PTC) currently has two openings on its Board of Directors. The May/June Board Meeting & AGM is the only in-person meeting, and Directors are reimbursed for all related expenses.

If more than two qualified candidates are nominated, an electronic ballot will be conducted, and the successful candidates will be presented to members at the PTC 2026 AGM in Toronto.
